Entries Close JULY 28, 2017. All entries not received by this point will be charged a penalty of \$30.00 per entry.
Late entries will ONLY BE ACCEPTED if stabling is available.

By entering the Old Home Week MBRA Show, you have agreed to honor the rules and regulations as specified in this prize list. You MUST abide by your own errors. Please READ carefully. You must be a member in good standing of the MBRA and agree to honour the rules, regulations and drug policies of the MBRA. The standard by which conduct of treatment will be measured is that which a responsible person, informed and experienced in generally accepted equine training and exhibition procedures, would determine to be neither cruel, abusive nor inhumane.

THE MANAGEMENT OF THE SHOW, PEI Provincial Exhibition Inc., Red Shores Race Track and Casino and the Eastlink Centre will not be responsible for injury to horse and/or rider. Each exhibitor is required to have liability insurance.

All entries in this show are governed by the rules of the MBRA, including the Drug Policy, copies of which can be found on the Website www.maritimebarrelracing.com

AUTHORIZED ADMISSIONS (passes) WILL BE REQUIRED FOR ADMISSION TO THE GROUNDS FOR EVERYONE (owners, trainers, competitors, grooms, etc.). Authorized Admissions (Week Pass) will be available for the cost of \$25.00. Each authorized admission is good for the duration of Old Home Week. AUTHORIZED ADMISSIONS MUST BE PURCHASED ON ENTRY FORM. Individual Day passes are available on the entry form at \$12 each.

1 (one) pass per horse per day entered will be provided at no cost.

ENTRY FORM must be signed by the person responsible for horse/rider. If the owner is under 18, the form must be signed by a parent/guardian. You will NOT be permitted to show if the entry form is not signed. Copy of Proof of Insurance must accompany Entry Form.

***** FAILURE TO STRIP YOUR STALL to the asphalt will result in FOREFITURE OF ALL PRIZE MONEY*****

With the development of a new parking lot just off of the Park Street lot, we are extremely pleased to be able to offer water and electrical hook ups to our exhibitors. We will be offering 1 trailer parking location with hook up per exhibitor, with priority given to those exhibitors from off island as space is limited. This location is at the end of the Park Street Lot, well within walking distance on the grounds. These spots will be offered at a rate of \$20/night. Camping with no electrical and water will be offered for free. **PLEASE SEE AN ATTENDANT BEFORE PARKING YOUR TRAILER. THERE WILL BE NO PARKING ON THE GRASS AREA AS IN PREVIOUS YEARS.** You will be asked to move your trailer if it is not in a designated camping area.

REFUNDS: A refund of 75% will be made upon receipt of a medical certificate either from a veterinarian or medical doctor. Must be received prior to first run.

ENTRIES may be refused an award unless they return to the ring for Class Presentation. Presentations will be made after the completion of each division. Forfeiture of any entry fees will occur for withdrawal or cancellation from the competition. The Old Home Week Show Committee has the right to refuse entries.

CHAMPIONSHIP awards and ribbons for each class/division, UNLESS otherwise stated. Recipients must be at presentation or may forfeit all prizes won.

STABLING will be provided on the show grounds for exhibitors at the following rates: (bedding is NOT provided but will be on sale on the grounds at cost) BOX STALL: \$40.00 (per show) STRAIGHT STALL: \$25.00 (per show) Box stalls will be assigned on a "first come, first served basis".

STALLS WILL BE ALLOCATED AND CHANGES MAY NOT BE MADE WITHOUT PERMISSION FROM THE SHOW OFFICE.

All horses must be groomed in their stalls, not in the aisles. There will be no washing or hosing of horses in the tent. Please do not hang coolers, etc on the outside of the stall partitions. This is an exhibition; horses should be seen by the public. Fire Marshall Regulations prohibit smoking in the barn areas. The consumption of alcoholic beverages in the barn area is prohibited.

Specific times have been stated for **arrivals and departures** of animals:

Arrival Time:

Thursday, August 10, 2017 5:00am until 9:00am (the arena will be open during lunch break on Thursday for MBRA competitors wishing to get in the arena prior to pre class warm up time).

Anyone arriving during competition times may be delayed in unloading while classes are taking place and holding areas are busy!!!

Departure Time:

Friday August 11, 2017 After last class of Penning

Saturday August 12, 2017 Must be **GONE** by 8am

COMPETITORS REQUESTING OTHER ARRIVAL TIMES MUST CALL AND RECEIVE PERMISSION FROM THE EXHIBITION OFFICE.

ALL HORSES COMPETING IN BARRELS OR POLES MUST LEAVE THE PROPERTY BY 8AM SATURDAY. THERE WILL BE NO STALLS AVAILABLE ON SATURDAY EVENING. IF YOU ARE ALSO PENNING, YOUR STALL MUST BE WITH RED DIRT CATTLE PENNING, NO EXCEPTIONS!!!

There will be NO PARKING on the grounds. Trailers must be parked in designated areas. Vehicles will be towed at the owner's expense if this rule is not followed.

ALL EXHIBITORS must be on the grounds one (1) hour before their class. The committee has the right to operate 1 hour early and make program changes. Exhibitors will be notified of any changes in the program by posters outside the Light Horse Show Office and over the PA system.

An MBRA approved number must be used in order to compete. Ring numbers must be worn and VISIBLE in the schooling area as well as the competition arena. Appropriate dress code must be respected by exhibitors, coaches and handlers in the show ring as well as the warm up area and holding area.

OLD HOME WEEK will not be responsible for non-payment of prizes (special or otherwise).

THE JUDGES DECISION IS FINAL.

COMPLAINTS must be presented to the OHW Office in writing within 24 hours of completion of the show accompanied by a \$50.00 deposit, which shall be forfeited if the complaint is not sustained.

PRIZE MONEY will be mailed out by OHW main office following the completion of OHW Exhibition. Please insure complete and correct spelling of mailing address.

Open RAM Rodeo Barrels Stake - \$1,000 Added to each of the 3 runs for a total of \$3,000 in prize money. Must be a MBRA member, in good standing, to show in these classes.

Open MBRA Old Home Week Poles Stake - \$500 added to each of the 3 runs for a total of \$1,500 in prize money. Must be a MBRA member, in good standing, to show in these classes.
